Finally, Sarec Group's servers automatically collect the information that the customer's browser customarily sends to any website it visits.

# **USE OF YOUR INFORMATION BY SAREC GROUP / SAREC SPORTS TRAVEL**

User's personally identifiable information submitted to www.sarecsportstravel.com will be used for the purposes set forth on www.sarecsportstravel.com; i.e. to register and arrange for reservations for the user and/or those traveling with the user as well as payment for same.

Sarec Group will not use customer's email address or other personally identifiable information to send commercial or marketing messages without customer's express consent.

Sarec Group may use certain non-personally identifiable information (such as anonymous user usage data, cookies addresse's, browser types) to improve the quality and design of the Sarec Group Travel web site and to create new features, promote functionality and services by storing, tracking, and analyzing user's preferences and trends.

Sarec Group uses cookies to remember information so that the user will not have to re-enter it during subsequent visits and to aggregate data such as total number of visitors, pages viewed, etc.

## WHEN SAREC GROUP DISCLOSES INFORMATION

Sarec Group / www.sarecsportstravel.com, will not disseminate or disclose personally identifiable information (such as names or email addresses) to other companies for their commercial and/or marketing use without users' consent, or, except as part of a special program or feature for which user will have the ability to opt-in or opt-out. Obviously, certain personally identifiable information must, however, be disclosed to the hotels and other service providers which are involved in the user's reservation(s).

Sarec Group may, with user's express written consent, share non-personally identifiable information (such as anonymous user usage data, URLs, platform types, etc.) with interested third-parties to assist them in understanding the usage patterns for certain content, services, advertisements, promotions, and/or functionality on Sarec Group website's.

Sarec Group may also disclose personally identifiable information and/or non-personally identifiable information if I required to do so by law, or in the good-faith belief such action is necessary to comply with state and federal laws (such as U.S. Copyright Law) or to respond to a court order, subpoena, or duly issued warrant.

Sarec Group reserves the right to disclose personally identifiable information and/or non-personally-identifiable information as is appropriate or necessary to enforce Sarec Group's Terms of Use, take precautions against liability, to defend its business against any third-party claims or allegations, to assist government enforcement agencies, to protect the security or integrity of our website, and/or to protect rights, property, or personal safety of Sarec Group or its users or others.

#### **PASSWORDS**
